*To use these forms you must be a resident of Multnomah County and at least 18 years of age.*

**CHANGING YOUR SEX**

Changing your legal sex\* is a simple court process involving three steps:

- (1) posting a public notice of the proposed change in the Courthouse for 14 days;
- (2) appearing briefly before a Judge who will sign the judgment; and
- (3) public posting of the change for the change to become official;

*\*NOTE: To order a legal sex change, the Judge must find that:*

- *You have undergone surgical, hormonal, or other treatment appropriate for you for the purpose of gender transition, and*
- *Sexual reassignment has been completed.*

**FEES**

The fee for the forms packet provided by the court is \$1.25. The court fee for filing a sex change petition is \$111.00. The charge for a certified copy of the General Judgment is \$5.00.

**INSTRUCTIONS**

Please read all instructions carefully. **DO NOT FILL OUT ALL THE FORMS AT ONCE. YOU WILL NEED TO COMPLETE THE FORMS AS YOU COMPLETE THE STEPS FOR THIS LEGAL ACTION.** These are legal documents that must not contain mistakes. Do not alter the documents.

**(First Visit To Courthouse)**

- STEP 1:      A. Fill out the PETITION FOR SEX CHANGE (Form 1)  
Please type or print.

**STOP.....DO NOT FILL OUT ANY MORE FORMS AT THIS TIME.  
FOLLOW INSTRUCTIONS.**

- B.      Sign the form in front of the Family Law Clerk, located in Room 211 of the Multnomah County Courthouse.  
Bring with you **one** form of valid photo identification – a current, state-issued driver’s license or identity card; current passport; current U.S. military identification card; current identity card issued by federally recognized tribe; or another current, government-issued document containing your photograph, signature, and physical description.
- C.      Go to the cashier, located in Room 210 of the Multnomah County Courthouse. Pay the \$5.00 certified copy fee and the \$111.00 court filing fee.
- D.      The cashier will give you a case number. Make sure the cashier puts the case number on all six forms.

- STEP 2      A. Complete NOTICE OF SEX CHANGE HEARING (Form 2). Leave the following spaces blank: room number, hearing date, time of hearing.
- B.      Take Form 2 back to Room 211. Use the telephone on the table and dial 83185. Ask for a Sex Change hearing date.
- C.      Fill in the hearing date on Form 2. Post Form 2 on the “IDENTITY CHANGE POSTINGS” BULLETIN BOARD in Room 211. This form must remain posted for at least fourteen (14) full days prior to the hearing.

**YOU MAY NOW LEAVE THE COURTHOUSE. YOU WILL RETURN  
ON YOUR HEARING DATE.**

**(Second Visit to Courthouse B on the Hearing Date)**

- STEP 3      A. Remove Form 2 (NOTICE OF SEX CHANGE HEARING) from the bulletin board in Room 211.
- B.      Complete the AFFIDAVIT OF POSTING NOTICE OF SEX CHANGE HEARING (Form 3) and sign it in front of the Family Law Clerk in Room 211. Remember to bring proper valid photo identification with you for this

purpose.

- STEP 4
- A. Complete the GENERAL JUDGMENT of SEX CHANGE (Form 4). Leave the following spaces blank: Judge's signature line and date. At the hearing, the Judge will decide whether there is any reason not to sign it. This form must be completed before you go to your hearing. Take forms 2, 3, and 4 to the court hearing. The Family Law Clerk in Room 211 will direct you to the appropriate courtroom.

After your court hearing, the judge will keep forms 2, 3, & 4 and instruct you to return to Room 211 to complete the process.

- STEP 5
- A. After your hearing, complete the NOTICE OF GENERAL JUDGMENT (Form 5).
  - B. Post Form 5 on the Identity Change Postings bulletin board in Room 211. (The Board is clearly marked.)
  - C. Fill out the AFFIDAVIT OF POSTING NOTICE OF GENERAL JUDGMENT (Form 6). Sign this in front of the Family Law Clerk in Room 211. Remember to bring proper photo identification with you for this purpose. The Family Law Clerk will keep Form 6 and file it with the court.

**IF YOU WANT MORE THAN ONE COPY OF YOUR JUDGMENT, PAY THE COURT CASHIER FOR THEM. EACH CERTIFIED COPY IS \$5.00.**

**(After Leaving the Courthouse)**

- A. A certified copy of your General Judgment of Sex Change will be mailed to you within one week of your hearing.
- B. You can use a certified copy of your General Judgment of Name and Sex Change as official proof of the changes for public agencies or as you might otherwise need.

Providing a copy to The Center for Health Statistics, P.O. Box 14050, Portland, OR 97239-0050, to change your birth certificate will be useful only if you were born in Oregon. If you were born in another state, you will need to contact that state to find out that state's requirements. Oregon Vital Statistics website info is available at:
